SCALE OF FEES AND EXPENSES of the



1. Membership Fee

- (1) According to § 8 of the statutes of the WTWU, each member pays an annual contribution to cover expenses. The amount is determined by the general meeting of delegates of the WTWU for the next calendar year. A budget plan can be submitted by the executive board of the WTWU in order to calculate the amount of the membership fee for the following year.
- (2) The amount of the membership fee results from the number of members per member association multiplied by the amount determined by the general meeting of delegates per one individual member of the member association.
- (3) The fixed amount per individual member of a member association for calculating the membership fee is € 0,50.

(Calculation example: A member association has 120 members. The amount per individual member is \in 0,50. This results in: 120 x \in 0,50 = \in 60,00 as membership fee).

The total contribution per member association and year must not be more than € 250,00, but also not less than € 30,00 per member association and year.

(4) The membership fee is calculated and invoiced by the WTWU based on the reported number of members.

- (1) The amount of the entry fee for all events of the WTWU is determined annually by the general meeting of delegates of the WTWU in accordance with § 12 paragraph 2 no. 22 of the statutes of the WTWU and amounts for participants send by members of the WTWU to:

3. Expenses of the general meeting of delegates of the WTWU

- (1) Pursuant to § 13 of the WTWU statutes, the regulation of the assumption of costs with regard to the general meeting of delegates of the WTWU (GMD) is as follows:
- (2) In the case of a face-to-face meeting, the costs for the venue of the GMD of the WTWU and for the drinks of the participants during the GMD will be defrayed in full by the WTWU. The persons involved must ensure that the costs are kept as low as possible.
- (3) All costs incurred by the delegates for participation in the GMD of the WTWU will not be defrayed by the WTWU. The regulation regarding the assumption of costs is the responsibility of the member association sending the participant.

4. Reimbursement of expenses/costs for executive board members of the WTWU

(1) Members of the executive board of the WTWU carry out their function on an honorary basis in accordance with § 14, paragraph 13 of the WTWU statutes. However, they are entitled to reimbursement of their actual expenses and costs incurred in the exercise of their function. The persons involved must ensure that the costs are kept as low as possible. The replacement is made by the WTWU.

5. Reimbursement of expenses/costs for department managers of the WTWU

(1) Department managers of the WTWU carry out their function on an honorary basis in accordance with § 18, paragraph 6 of the statutes of the WTWU. However, they are entitled to reimbursement of their actual expenses and costs incurred in the exercise of their function. The persons involved must ensure that the costs are kept as low as possible. The replacement is made by the WTWU.

6. Reimbursement of expenses/costs for WTWU arbitrators and assumption of costs of the proceedings

- (1) According to § 20 of the statutes of the WTWU, an arbitral tribunal can be appealed to in defined disputes. Arbitrators and the chairman of the arbitrators of the WTWU carry out their function on an honorary basis. However, you are entitled to reimbursement of the actual expenses incurred. The persons involved must ensure that the costs are kept as low as possible.
- (2) The costs of the proceedings and the cash expenses of the arbitrators are defrayed by the losing party or, in the case of a settlement, by both parties in half.

7. Assumption of costs for judges, stewards, supervisors and other special assistants

- (1) The costs for the judges, main stewards, supervisors and other persons named below in the course of international events are defrayed by the organizing member association of the WTWU in all sports. These are set as follows:
 - a. daily allowance:
 - i. Daily allowance per day of activity for various officials (e.g. judges, track layers, protection helpers etc.) in accordance with the usual requirements of the respective host country.

b. Traveling expenses:

- i. Kilometer allowance for various officials (e.g. judges, supervisors (e.g. track supervisors), main stewards (obedience), protection helpers, track layers) in accordance with the usual requirements of the respective host country.
- ii. Other travel expenses according to receipt (e.g. flight, train, etc.)
- iii. The journey is to be coordinated with or arranged by the organizer.
- iv. It is always the cheapest means of transport and the most direct way to be chosen. However, if a more expensive means of transport is chosen or a detour that is not necessary for the journey, reimbursement of costs will only be made for the cheapest or most direct journey.
- v. Costs for accompanying persons are not covered.

c. Accommodation costs:

- i. according to receipt (for judges, supervisors (e.g. track supervisors), main stewards (obedience), protection helpers, track layers)
- ii. The overnight stay is to be coordinated with the organizer or arranged by him.
- iii. It is a cheap but appropriate accommodation to be chosen. If a more expensive accommodation is chosen, reimbursement of costs will only be made for the cheaper accommodation.
- iv. Costs for accompanying persons are not covered.

d. Board:

- i. Free catering in the form of food and drinks during the event and at the event location (for judges, supervisors (e.g. track supervisors), main stewards (obedience), protection helpers, track layers, trial secretary) in accordance with the usual requirements of the respective host country.
- (2) Each organizing member association of the WTWU is free to voluntarily assume the costs for other helpers of the event not mentioned here.

8. Deposit in the event of objections raised in the course of WTWU events

(1) If an objection is raised in the course of a WTWU event, the person raising the objection must pay a deposit of € 300,00, which expires in favor of the organizer if the objection is rejected.

9. Assumption of costs for inviting the executive board and the respective department manager of the WTWU to WTWU events

- (1) Both the chairman of the WTWU and the responsible department manager of the WTWU must be invited to WTWU events. The organizer of the event bears the costs for accommodation and travel expenses in accordance with the specifications in point 7 paragraph 1 lit. b) and c).
- (2) Members of the WTWU executive board and the responsible department manager of the WTWU are to be granted free access to the event.
